

# EA+<sup>®</sup> Expanded Evacuation

**The following services are available when you are Traveling Away From Home and Outside The United States.**

**Emergency Security or Political Evacuation/Repatriation:**

If you are Traveling Away From Home and Outside The United States and your current international location is being threatened by a Security or Political Emergency Situation due to governmental or social upheaval, EA+ will arrange and provide transportation to remove you from the area. Emergency Political Evacuation/Repatriation services are provided by EA+ security personnel to the nearest safe location, and then to your Home, if needed. The decision to Emergency Evacuate/Repatriate due to a Security or Political Emergency Situation will be made by EA+ security personnel in consultation with local governments and security analysts. This service is only available when you are Traveling Away From Home and Outside The United States, and you cannot obtain commercial transportation to the nearest safe location within a time period which will enable you to leave the foreign location in time to avert Imminent Bodily Harm or to comply with the time allowed to leave the foreign country pursuant to the orders of the recognized government of that foreign country.

In the event you are in an area in which an act of rebellion, riot, military uprising, war, terrorism, labor disturbance, strike, nuclear accident, or interference by authorities inhibits EA+'s ability to fully provide services, EA+ shall nonetheless use its best efforts to provide its services, recognizing that obstacles beyond its control will affect the level of service. EA+ cannot be held responsible for failure to provide services or for delays caused by strikes or other conditions beyond its control including, but not limited to, flight conditions, or where rendering of service is prohibited by local laws or regulatory agencies.

**The following services are available when you are Traveling Away From Home.**

**Natural Disaster Evacuation/Repatriation:**

If you are Traveling Away From Home and your current location has been impacted by a Natural Disaster Situation, EA+ will on a best-effort basis arrange and provide an evacuation from a safe departure point EA+ designates, to a safe haven of EA+'s selection and then to your Home, if needed. If evacuation becomes impractical due to hostile or dangerous conditions, EA+ will maintain contact with you and advise you until evacuation becomes viable or the Natural Disaster Situation has passed. This service is only available when you are Traveling Away From Home.

EA+ will only arrange and provide a Natural Disaster Situation evacuation up to and including seven (7) days from the date the official disaster declaration was issued.

EA+ retains the discretion to limit one (1) emergency evacuation and/or repatriation attributable to any single Security or Political Emergency Situation and/or one (1) emergency evacuation and/or repatriation attributable to any single Natural Disaster Situation per eligible Member.

## DEFINITIONS

“Home” means the locale of the address as shown on your state driver’s license or state-issued identification card.

“Host Country” means the country to which you have traveled and which is not the United States.

“Imminent Bodily Harm” means the existence of any condition or circumstance, which cannot be avoided through reasonable precautionary measures, and could be expected to cause death or serious physical harm to you, if you were to remain in the affected area where the Political or Natural Disaster event has occurred.

“Member” means the primary person validly enrolled for EA+ and for whom Worldwide Rescue & Security, Inc. has received the appropriate membership fee. Under Family Memberships, Member shall include Spouse and Dependent(s).

“Natural Disaster Situation” means an event occurring directly out of an event of natural cause, including wildfire, earthquake, windborne dust or sand, volcanic eruption, tsunami, snow, rain, or wind, that results in widespread and severe damage such that the government of the Host Country and/or the local government issued an official disaster/emergency declaration and determines the affected area to be uninhabitable. Natural Disaster does not include the direct or indirect effect of rain, wind, or water associated with named storms meeting the definition of hurricane or typhoon, except in instances where:

- a. the path of the named storm deviates by a distance of greater than 200 miles within a 72-hour period from the path forecast by a national recognized meteorological service; or
- b. less than 72 advance hours’ notice of a potential landfall for a named storm exists.

In no event, shall a Natural Disaster be deemed to apply to a marine vessel, ship, or watercraft of any kind.

You will not be eligible for Natural Disaster Evacuation services:

1. Prior to the occurrence of the Natural Disaster.
2. If you chose to stay in your location once an evacuation order was issued.
3. After the occurrence of the Natural Disaster if commercial transport to a safe location is available to you.

“Outside The United States” means any location outside of the 50 states.

“Security or Political Emergency Situation” means:

1. Officials of the foreign country or the embassy of the country with which you are a national has issued for reasons other than medical, a recommendation that categories of persons which include you should leave the foreign country; and/or
2. You are being expelled or declared persona non-grata on the written authority of the recognized government of the foreign country; and/or
3. The security, political, and/or military events in the foreign country has created a situation in which EA+ has determined you are in danger of Imminent Bodily Harm to the extent that you must be removed from the location; and/or
4. You cannot obtain commercial transportation to the nearest safe location within a time period which will enable you to leave the location in time to avert Imminent Bodily Harm or to comply with the time allowed to leave the location pursuant to the orders of the recognized government of that foreign country.

“Traveling Away From Home” means on a vacation or business trip away from your Home (by car, plane, or other mode of travel), for a purpose other than your normal daily activities or routine. Washington state residents must be traveling more than 100 miles away from Home to be eligible for EA+ services.

“You” and “Your” means Member with regard to Individual Membership and means Member, Spouse, and Dependent(s) with regard to Family Membership.
