

The EA+ Travel With Confidence Sweepstakes

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

Entry Period: The EA+ Travel With Confidence Sweepstakes (“Promotion”) will begin at 12:00 pm Eastern Time (“ET”) on April 15, 2026 and end at 11:59 pm ET on April 29, 2026 (“Entry Period”). The Promotion will consist of a random draw sweepstakes as outlined below.

Who is Eligible: Open to legal residents of the fifty (50) United States and the District of Columbia, who are 18 years of age or older as of April 15, 2026. Promotion participation open to new Emergency Assistance Plus members, non-members, and current members. Employees, officers, directors and agents of AGIA, Inc. (Sponsor), Prize Promotions, LLC (“Administrator”), DOXA Company, and each of their respective parents, affiliated companies, subsidiaries, distributors, dealers, retailers, printers, advertising and promotion agencies and any and all other companies associated with the design or execution of this Promotion (collectively, the “Promotional Parties”), and the members of their immediate families (spouse, parent, child, sibling and their respective spouses, regardless of where they reside) or households, whether or not related, of any of the above, are not eligible to enter or win. How to Enter: During the Entry Period, visit www.emergencyassistanceplus.com/lp/sweepstakes (the “Website”), or a Promotion link on a Sponsor-related social media webpage, mobile application or e-advertisement and follow the instructions to complete and submit the online registration form to receive one (1) entry (each, an “Entry”).

Entrants that have elected to opt-in to receive marketing communications from Sponsor on the registration form may opt-out of any further communications at any time by following the opt-out instructions provided in the applicable communication. Any available opt-in opportunities are optional and not required to participate in the Promotion, and checking the opt-in boxes will not increase your chances of winning. By submitting an Entry, entrant agrees that Sponsor and any other participating parties are authorized to contact entrant via email or any other form of media to make entrant aware of information pertinent to the Promotion, and to distribute information regarding the Sponsor featured products, special events or promotional offers, or purchase incentives, provided entrant has opted-in to receive such information. Entrants may opt-out of any further email communication at any time by simply following the provided opt-out instructions in email.

All Entries must be received by 11:59 p.m. ET on April 29, 2026 to be eligible. Limit of one (1) Entry per person, per household, and per email address throughout the Entry Period, regardless of method of entry. Entries generated by script, macro or other automated means and Entries by any means which subvert the Entry process will be void. Entries that are incomplete or corrupted are void and will not be accepted.

Winner Selection: A random drawing will be conducted by the Administrator on or about April 30, 2026 to select one (3) potential Grand Prize winner from among all eligible entries received in accordance with these Official Rules. Odds of winning depend on the number of eligible entries received. Potential Grand Prize winner will be notified by phone and/or email beginning approximately on or about April 30, 2026 and asked to confirm their eligibility and indicate their willingness to accept the Grand Prize as described below. No voicemail will be left. Upon confirmation of their eligibility as well as their willingness to accept prize, such potential Grand Prize winner will be required to execute and return a W-9 form, an affidavit of eligibility and liability and, unless prohibited by law, publicity release within three (3) days of date of issuance of notification. If potential Grand Prize winner is ineligible or otherwise fails to return such documents within the specified time period fully-executed, or if Administrator is unsuccessful to reach and speak directly with the potential Grand Prize winner by phone and/or email over a 24-hour period, or potential Grand Prize winner cannot or does not wish to accept the prize or is not in compliance with these Official Rules, such

In the event the Promotion is terminated, Sponsor reserves the right to award the Grand Prize only for a valid and eligible prize claim submitted up to such termination. In the event a dispute as to a registration submitted by multiple users having the same e-mail account, the registration will be deemed made by the authorized account holder of the e-mail address submitted at the time of registration, and such person will be required to meet the eligibility requirements of these Official Rules.
